<p>85/20 Public Forum</p> <p>85/20/01 Chair passed on condolences to Cllr. Clough on the loss of her husband David, Cllr. For Glapwell Parish. A donation of £100 was offered to a charity in David's name. Cllr. Clough was honoured to nominate David's two chosen charities Médecins sans frontières and Derbyshire Asbestos Support Team.</p> <p>Cllr Fleetwood wished to report problems with red bins being left across driveways on The Hill leading to situations where vehicles are being left in the road and vulnerable to collisions. Cllr. Clough also mentioned the delays to red bin collections which have occurred in the previous weeks.</p> <p>Clerk to write a formal letter to BDC expressing these concerns.</p> <p>Cllr Fleetwood wished to raise the issue of residential problems involving a family in the village (address withheld). A large grab bag has been sited outside on the communal grass and attempts to request its removal have been met with abuse. There are also issues with noise and behaviour. Cllr. Clough reported that this was already being dealt with being dealt with by police and council</p> <p>Clerk to write a formal letter to BDC to lodge its concerns.</p>
86/20 Minutes of previous meeting October 22 nd 2020 – Minutes were accepted as a true and accurate record.
<p>87/20 Reports:</p> <p>87/20/01 Police report</p> <p>Reports of crime have risen August 2020 to September 2020 up by 50%. Reports of crime for September 2020 are down 40% on 2018 and 2019. Cllr. Fleetwood asked if the Council had received any reports regarding the anti-social behaviour by the aforementioned family (85/20/01)</p> <p>Clerk to send letter of complaint to the police</p> <p>87/20/02 County Councillor</p> <p>Further monitoring of Back lane has not been possible due to lockdown.</p> <p>Money has been given to the football club for goalposts. Grant of £500.</p> <p>HS2 Seems to have been put on hold so nothing further to report there.</p>

87/20/03 District Councillor

Pleased to announce that at a Budget scrutiny at BDC it was announced that they are issuing tranche 4 grant payments. Glapwell has received £8548.

Have attended a co-op party meeting and met with Joshua Ludlum who gave a good presentation on how co-ops can help with small grants and liaise with different communities. His presentation may be good to hear at another parish council meeting. Simon Redding was there and I will be meeting Simon with Tom Kirkham at some point towards the end of December.

Cllr Trafford shared news that Seven Trent fund would be a good approach for help in raising funds to redevelop the Glapwell Centre but they wanted to be the major contributor. A phased approach to development would allow this to happen. We could then knit together a patchwork of investors. A start up grant would allow us to undertake surveys and consultations and draw up a development plan. First step is to consult local community and identify if the plan of 9 years ago needs modifying. Ideally we would be looking at a full demolish and redevelop plan.

Cllr Jepson reported that the Church View street sign was broken. Cllr. Clough to report.

88/20/01 Christmas tree

Had the quotes in and discussed at length with Tony and John and subsequently placed order with contractor. Foundations are in and tree going up tomorrow. Lights on are solar powered. Peter White of Vault Security are contributing £500.

88/20/02 Glapwell in Bloom

Cllr. Fleetwood – Met Roger Owen who has no objections to area opposite the Young Vanish for planting formal beds and will get a licence to me early part of new year. Looking in terms of 3 circular beds and already got sponsorship for two of them and with luck hoping to get third sponsor. They won't pay for whole costs in first year but certainly pay for planting.

88/20/03 Doctors Surgery

Cllr. Fleetwood – Again walking round estate people have been positive about the doctors using the hall for flu vaccine and they thought it was much better than having to go to Bolsover. Can we offer facility every year and for any potential covid vaccine as well, free of charge? Surgery have health and wellbeing free of charge and can we ask whether they are prepared to put on health and wellbeing at the centre free of charge for a 3 month pilot? Stay and have coffee biscuit afterwards to address loneliness then extending this to parent and toddler weighing clinic.

Cllr. Trafford– If we are to raise funds for a rebuild and we can demonstrate need it helps with external funding.

88/20/04 Wildflower Planting

Cllr. – There are a number of places nominated with some objections on highways. Cllr. Moesby may be able to help with looking at highways objections. We think there is a sufficient 2 metre visibility however, Steve suggests the peace garden at top of steps is suitable and also the sloping area near steps.

Cllr. Clough - The area off Maple grove between bungalows may be promising?

Cllr. Fleetwood - Steve Brunt said that areas within estate not conducive to wildflower planting

Cllr. Clough – Nick Clarke could do with being consulted.

Cllr. Fleetwood – 7 sites have been identified to start with and five we have good grounds to go ahead.

Cllr. Moesby – Let me know the areas not suitable and I will consult highways.

Cllr. Fleetwood – Can always look at garage sites for allotments.

- REMOVE your dogs' poo immediately from all public places across the whole District.

- YOU MUST, whilst you are in charge of a dog, carry appropriate bag(s) or receptacle to remove their dog poo.

Cllr. Fleetwood – Vault invoiced incorrect amounts have they now been revised?

RFO– Both Clerk and I have queried and they have said its correct

Cllr Fleetwood proposed that in view of the community support received from Vault this invoice is paid as is. This was agreed to by all present members.

89/20/02 Income and expenditure October

Reserve sitting at £64770.48

RFO – Pleasantly surprised when it came out that close given that back in April/May expecting less in reserves. The Government support with wages has kept us afloat and our overheads have come down. Therefore we have built several projects in to the budget.

89/20/03 Budget monitoring

RFO - Lock down continues to affect income. Nothing in for November. October was OK but covered longer bookings so they will need to be rolled forward. Hoping that come end of year we will see 32k in reserves which carries us forward well. Will wait to see its not easy to forecast.

89/20/04 Budget setting

Draft budget:

Looking at reserve I've built in income of £8000 but we don't know if they will be there given the pandemic. Have put in peppercorn rent at £150, that's not been agreed but that looks about average. The additional £8500 is in so that now adds to it. But looking at spending staffing etc. it's been built in based on the year before last and really, we are looking at covering those costs. Hopefully there will be more income. But in order to maintain we need to set a precept of around 7% if we want to look at £22000 reserve in 2022. So, we will be down on reserves in 2022 but hopefully there will be more income. A 7% band D increase is equivalent to £9.21 so just 18p a week.

Cllr. Fleetwood – I don't think we will be down at 2022. Not withstanding the issues over staffing I think we'll see savings. Its how promote the centre to get people in. For example, the Creche and GP fitness. I think they'll be more than 8k on lettings. Hope I can say told you so but 7% not a problem
RFO – GP fitness do not bring in money.

Cllr Trafford – Is 7% politically a problem? General costs not going up and a hard time for the electors.

Cllr. Fleetwood – All the projects we've not had for couple of years provided we supply those hanging baskets etc. We've got to do what we've identified. For that 18p we've got to say you will get "this".

Clerk – Proposed a calendar of events made public

Cllr. Fleetwood– Can we do something near the Christmas tree this year?

Cllr. Trafford– I'm hearing that everyone is comfortable with 7% and a calendar of events which we should produce. Can we do anything specific this year at the vanish this year and then make it a regular Christmas event?

Cllr. Mellard Sibley – Carol singing is allowed as in door to door socially distanced outdoor carol singing.

Cllr. Clough – There is no singing allowed at Dave's funeral so how they will do that I don't know.

Clerk – Will look into what is allowed.

Cllr. Jepson – Would there be any problems with where and when you sing round it?

Cllr. Hibbert – Children close to road is a problem would need a good 6 metres. And children only with parents. Would also need a barrier along the road, two or three crowd barriers along highway.

Approval of budget as 7% precept. Propose: Cllr. Fleetwood; Seconded Cllr. Clough

90/20/01 Update on refurbishment plans

Cllr Fleetwood - No joy from REAL and they are not responding to complete the works. It is 95% complete. Sports hall high level work still outstanding as was arrival of chairs and tables and laptops.

Councillors were invited to arrange a tour with Julie.

Clerk to arrange change of code given REALs departure.

Cllr Trafford There has been a good response to the Food bank collections that Julie has organised. We may want to consider a food co-op. You join a group and choose what you take from a food bank and sell this on at low levels of cost becoming self-sustaining. We could offer to be a base for one of those projects, offer space for us to be a base.

Cllr. Hibbert – Are the council interested in partitions for display boards? Using for centre for injections, health and wellbeing and with notices. Council will receive these gratefully.

Thank's were given to Cllr. Fleetwood for erecting the Remembrance soldier and flags.

91/20/01 Charity Formation update

Its is formed and running. RFO Going through bank account opening. Applied to Cllr. Moesby for small money grant of £250 for the charity covering cost of lock system. Helpful. Money would go into BCVS temporary account.

91/20/02 Ground update

Cllr. Mellard Sibley - Not much going on, football temporarily halted and December is quiet for grassroots. Only one game in December from a playing perspective. From organisation and ground development tings have been happening. Met jamie yesterday. Been working hard on the coffee shop area. Rodent infestation has been dealt with. Several funding pots have been identified. One to cultivate the grass was applied for and signed off and now sits with Derbyshire FA but not much happening the FA are starting to furlough so slowing down. New goal posts are being sourced to circumvent health and safety issues. Looking at the changing room and a facility grant, clubhouse repairs, pitch side and

floodlights. Mindful that the majority of equipment belongs to Phil and what doesn't work is a Health and safety issue. Liam who is Jamie's brother is helping Phil. But we want to make sure we are covered for the future. Cllr. Moesby has issued £500 Not much football. The only complaint is they can't get on the MUGA, but MUGA will be the best source of income.

Cllr Fleetwood – Phil Davis says he has sourced boilers for changing room. Had good chat with Jamie who knows someone to install them who is fully certified gas. They will want to see boilers first and put together proposal and only when certified will they go in.

Cllr. Mellard Sibley –I'm happy to run with it as Health and Safety is being fully covered. He will put his name to it.

Cllr. Trafford – We have made it clear had to be certified.
